Each 100 ml contains:
Chlorhexidine di-gluconate 0.10 gm
Hexamidine di-isethionate 0.10 gm
Chlorocresol 0.30 gm

Indications:
Antiseptic Foaming Solution

Contraindications:
CYTAROSE is contraindicated in patients with known hypersensitivity for any ingredients of the product.

Precautions:
CYTAROSE is designed for external use only. There is no evidence of any adverse effects on the fetus arising from the use of CYTAROSE during pregnancy or lactation; therefore no special precautions are recommended during pregnancy or lactation.

Adverse effects:
CYTAROSE is well pH balanced tolerated formula but in rare cases sensitivity may develop in certain individuals. If irritation, discomfort, redness, swelling or other signs of sensitivity occur the patient should discontinue treatment.

Dosage & Administration:
CYTAROSE could be used directly or diluted with water to 1:10 .

In gynecological diseases :
Use without dilution then wash or use diluted to 1:10 as vaginal douche
1 - 2 times daily for 7 - 14 days.

Primary skin diseases:
Use without dilution for cleaning then wash the skin with water or use diluted to 1:10 in dermatological inflammations.

In surgery :
Use as diluted to 1:10 for cleaning and disinfection of wounds .

Hands disinfections:
Use without dilution and rinse thoroughly with water .

Package:
Bottles of 250 ml

Storage:
Store below 25 °C.
Keep away from direct light.
Keep out of reach of children.
